- Cedric moved to review the 2 clubs that submitted after the posted deadline. Joel seconded. No objections. The motion was passed by consensus.
- Cedric moved to leave out the African Cultures Club for reviewing because the club haven't submitted their constitution. Will seconded. No objections. The motion was passed by consensus.
- Cedric moved to reject the Diversity in Business Club because the club did not fulfill the minimum of 10 members in their petition and the club submitted their forms and documents after another similar business club. Joel seconded. No objections. The motion was passed by consensus.
- Ruchira moved to approve the Best Buddies at De Anza. Joel seconded. No objections. The motion was passed by consensus.
- Cedric moved to approve the De Anza Dunkaroos. Ruchira seconded. No objections. The motion was passed by consensus.
- Cedric moved to deny AutonomX. Ruchira seconded. Joel objected. Rejecting the AutonomX at De Anza is put to a vote. 4 voted for the motion, 1 voted against, no one abstained. The motion was passed by majority vote.
- Cedric moved to approve the B.I.E.N. Joel seconded. No objections. The motion was passed by consensus.
- Cedric moved to approve De Anza Soccer Association. Joel seconded. No objections. The motion was passed by consensus.
- After review of all Spring applications, it was found that ICC has enough funds for 6 rather than 5 new clubs. Cedric moved to approve Women in Business and ASCII Graphics Game Clubs for the final 2 new club account spots. Joel seconded. No objections. The motion was passed by consensus.
